FARM CONFERENCE '92

Santa Rosa has been selected as the site for "California Farm Conference '92". The annual statewide conference, which provides information on direct marketing, agricultural sustainability and family farm issues, is scheduled for Friday through Sunday, February 7-9.

The conference is designed for farmers, farmers' market managers, researchers, policy makers, educators and others involved in small-scale agriculture.

Activities include all day short courses, tours, lectures and workshops. Workshop speakers include farmers, market managers, University of California farm advisors and specialists and organization representatives. A sampling of workshop topics includes:

- * Festivals, farm trails and on-farm promotions
- * Safe and legal ways to dispose of ag chemicals
- * Berry production
- * Marketing specialty livestock products
- * Soil fertility the sustainable approach
- * New organic certification laws
- * Specialty seeds for value-added specialty markets
- * Working with the health department
- * Establishing a certified farmers' market
- * Uncommon fruits worthy of attention
- * Pheromone confusion: a pest control technique for apples, pears and walnuts
